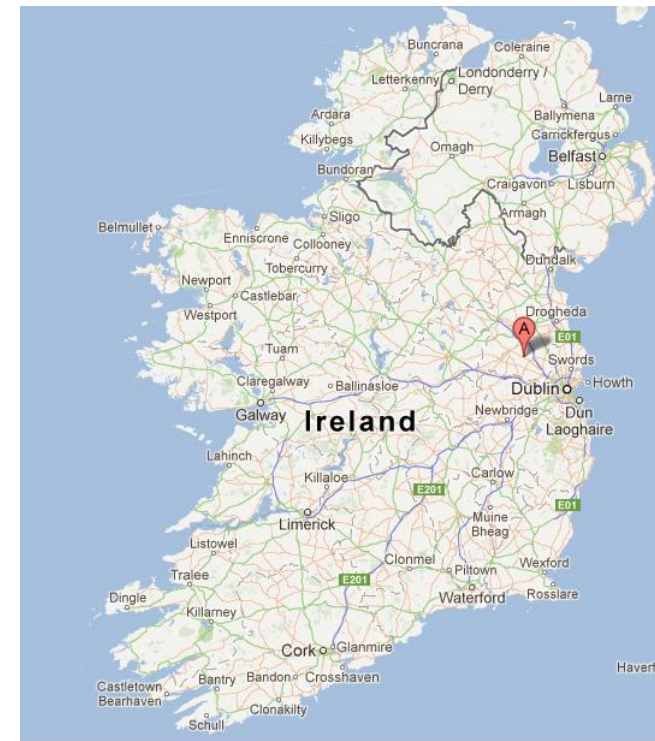

# The Food and Veterinary Office (FVO)

- **FVO carries out audits to verify compliance with EU standards in animal health and welfare, food safety and plant health**
- **FVO's office is in Ireland**
- **160+ staff (50% inspectors)**



## **FVO (cont.)**

- **FVO is one of seven Directorates of Directorate-General Health and Consumers (DG SANCO)**
- **DG SANCO is one of 33 Departments of the European Commission**
- **DG SANCO is based in Brussels and has around 900 staff in seven Directorates**

# An FVO audit

- **Basis = EU legislation**
- **The system as it should be:**  
**Information from Competent Authority**  
**- before and during the visit**
- **The system in practice: visits on-the-spot**

**An assessment - based on sampling - of the performance of the Competent Authority (CA)**

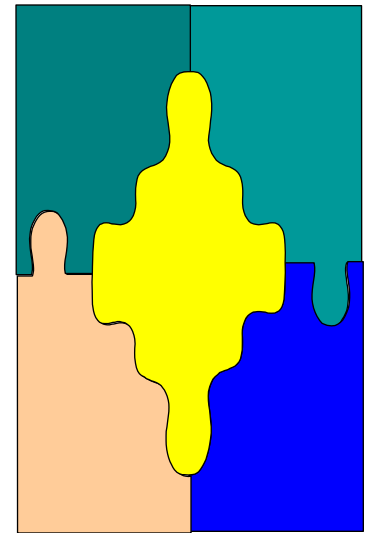
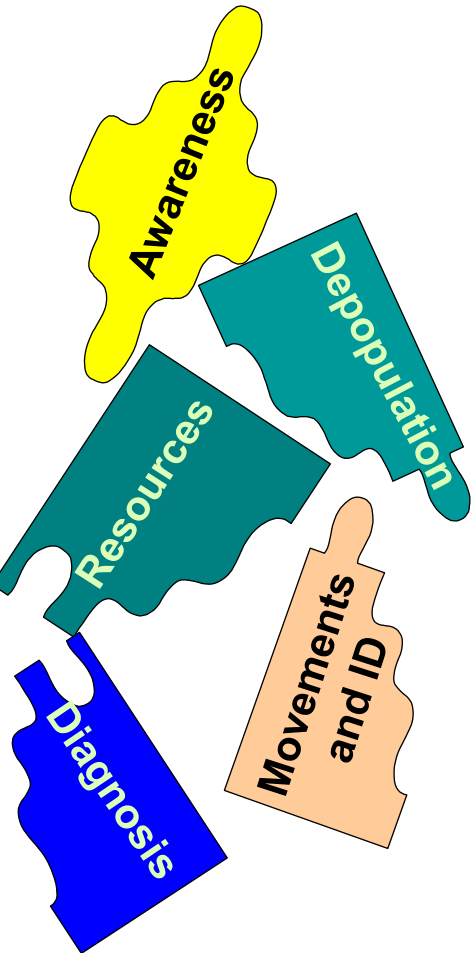


**Simply:**

# FVO and contingency planning (CP)

- Council Directive 92/35/EEC – African Horse Sickness
- Council Directive 92/66/EEC – Newcastle Disease
- Council Directive 92/119/EEC – other OIE listed diseases
- Council Directive 2000/75/EC – Bluetongue
- Council Directive 2002/60/EC – African Swine Fever
- Council Directive 2001/89/EC – Classical Swine Fever
- Council Directive 2003/85/EC – Foot-and-Mouth Disease
- Council Directive 2005/94/EC – Avian Influenza
- Council Directive 2006/88/EC – Aquatic Animal diseases

# The current EU CP-legislation

- Differences in wording, phrasing, scope, depth, details and structure of the requirements for contingency planning (not necessarily related to the specific disease conditions)
- FMD - the most advanced requirements
- The new EU Animal Health Law will contain general provisions for CP

# Chain of command



- ✓ Overall direction of control strategies
- ✓ Delegation of duties
- ✓ Deployment of staff
- ✓ Liaison with diagnostic laboratory
- ✓ Communication: media, EU, MS, OIE....
- ✓ Liaison with livestock industry, veterinarians, etc.

## 2012-2013 audits

**Implementation of the CPs, with particular focus on:**

- ✓ **CPs for all epizootics / emerging diseases?**
- ✓ **Simulation exercises**
- ✓ **Surveillance, early detection**
- ✓ **Depopulation (Council Regulation (EC) No 1099/2009)**
- ✓ **Preparedness for emergency vaccination**

# 2012-2013 audits

## Taking into account:

- ✓ **Identification of examples of best praxis**
- ✓ **Problems common to a number of MS**
- ✓ **Anomalies in current legislation**
- ✓ **Suggestions for consideration when subordinate legislation under the new Animal Health Law is drafted**
